This letter will serve to confirm that California College of Music gained accreditation in 2019 and is currently an accredited institutional member in good standing of the National Association of Schools of Music (NASM).

The most recent comprehensive institutional review was conducted in 2018. The next comprehensive institutional review is scheduled to be conducted during the 2024-2025 academic year. The institution is current as of this date with all obligations of institutional membership regarding annual reporting.

NASM includes in its Directory List the following approved programs offered by the institution:

Certificate in Performance (Undergraduate) – 60 quarter-hour credits.

Certificate in Songwriting and Music Production – 60 quarter-hour credits.

Associate of Science in Performance – 90 quarter-hour credits.

The California College of Music submitted the Apprentice in Music Performance program requiring 30 quarter hours in its Self-Study in 2019. This curricular program was reviewed by the NASM Commission on Accreditation as part of the institution's comprehensive review. Given the NASM listing requirements (see *NASM Handbook 2022-23*, Rules of Practice and Procedure, Part II, Article I., Section 3.), and the number of credit hours required for this program (30 quarter hours), this degree is not listed in the institution's NASM Directory Listing.

Please note, postsecondary non-degree-granting programs offered by degree-granting institutions will be listed by NASM only when their objectives and structure indicate a discrete curricular offering and when they require 45 or more quarter hours at the undergraduate level. When the purpose is to offer shorter programs of a workshop nature, or programs that provide supplemental credentials for students enrolled in undergraduate or graduate degree programs, the programs will be reviewed by the Commission on Accreditation, but not listed by the Association (see *NASM Handbook 2022-23*, Rules of Practice and Procedure, Part II, Article I., Section 3.).
